Subcontractor hereby represents that the amount stated for work performed and materials supplied as shown on Line 6 of Subcontractor's Application for Payment No. \_\_\_\_\_ ("this Application") represents the actual value of accomplishment under the terms of Subcontract No. \_\_\_\_\_, and all charges thereto ("Subcontract") between Subcontractor and Doster Construction Company, Inc. ("Doster") through the end of the period for which this Application is submitted. No other amounts are claimed to be due or are due from Doster except as listed on this Application, the accuracy of which is hereby verified under oath.

3. Subcontractor represents that all work and materials for which payment is sought in this Application strictly complies with the requirements of the Subcontract and all items incorporated therein by reference, including, but not restricted to, the Plans and Specifications for the Project.

4. Upon Subcontractor's receipt of the amount shown as currently due on Line 11 of this Application, as acknowledged by Subcontractor's endorsement and negotiation of Doster's check in said amount, Subcontractor releases and discharges Doster, the owner of the Project, and their respective sureties, officers, directors, agents, and employees (hereinafter collectively referred to as "Releasees") from any and all claims, debts, disputes, causes of action, and controversies, both known and unknown (except retainage shown on this Application): (a) arising in any way from, or on account of, Subcontractor's performance of work or furnishing of materials at or for the Project through the end of the period for which this Application is submitted; or (b) that have otherwise accrued or arisen (in whole or in part) on or before said date. Subcontractor acknowledges that, except as shown on this Application, no other amounts are or will become due on account of work, materials, or costs furnished or incurred through the end of the period for which this Application is submitted.

5. Without restricting the scope and generality of the foregoing release, Subcontractor hereby waives, releases and relinquishes any and all liens and rights to claim any liens which Subcontractor, or anyone claiming by, through or under Subcontractor, may have now or in the future on account of work, materials, or costs furnished or incurred through the end of the period for which this Application is submitted, against: (a) the Releasees (or any of them); (b) any funds that may be or become payable to Doster; or (c) the Project.

6. Subcontractor hereby represents that all payments due, less applicable retention, have been made through the periods covered by previous payments received from Doster: (a) to all of Subcontractor's subcontractors; and (b) for all labor and materials procured or used in or in connection with the performance of the Subcontract. Subcontractor further represents that he has complied with all federal, state and local laws, including tax laws, Social Security laws, Unemployment Compensation laws, and Workmen's Compensation laws, insofar as applicable to the performance of the Subcontract, and has paid all applicable union obligations. Subcontractor shall indemnify, defend, and hold Doster harmless from and against any claims, liens or damages alleged or asserted by Subcontractor's subcontractors, suppliers, work forces or other.

7. Subcontractor acknowledges that this Release, Waiver of Lien, and Affidavit is given to Doster to induce Doster to make payment on this Application, and that Doster will rely on Subcontractor's representations and undertakings herein.
